SUMMARY ANNUAL REPORT FOR MCASF LOCAL 725 DEFINED CONTRIBUTION RETIREMENT PLAN

This is a summary of the annual report Form 5500 Annual Return/Report of Employee Benefit Plan of MCASF Local 725 Defined Contribution Retirement Plan and Employer Identification Number 58-2490173/Plan Number 003 for the plan year 01/01/2023 through 12/31/2023. The Form 5500 annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a multiemployer, defined contribution plan with the following characteristics: ERISA section 404(c), code section 401(k) feature, 401(k) or 403(b) plan that provides for automatic enrollment.

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$2,667,259. These expenses included \$536,237 in administrative expenses and \$2,131,022 in benefits paid to participants and beneficiaries. A total of 1,534 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$64,877,542 as of the end of the plan year, compared to \$56,980,124 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$7,897,418. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$10,564,677, including employer contributions of \$1,756,459, employee contributions of \$1,206,351, gains/(losses) of -\$127,622 from the sale of assets, and earnings from investments of \$7,729,489.

- 5. Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates.
